Ahmedabad: Gujarat again emerged as the top performer in the States' Startup Ranking 2022: National Report by Department of Promotion of Industry and Internal Trade (DPIIT) of the ministry of commerce and industry. The report was launched by commerce minister Piyush Goyal on Tuesday in New Delhi.

In Category A - comprising states with a population of more than 1 crore — the best performers included Gujarat, Karnataka, Kerala and Tamil Nadu.



SUSTENANCE: Rs 10,000 per month will be provided to the innovator as sustenance allowance for a year

 Eligible incubators shall get support for recurring expenses as operational assistance up to 50% of actual expenses with Rs 5 lakh per year being the upper limit

INFRASTRUCTURE: Innovators can use facilities available in the recognized institutions for startups

Eligible host institutes shall be provided capital grant of maximum 50% of fixed cost of investment (made in equipment but excluding land and building) to set up an incubator for a maximum of Rs 50 lakh

MENTORING: Recognized institutions will provide mentorship to innovators. Government will help innovators get free access to university/ libraries/government laboratories/ SDCs (GIDC)/CoE/PSUs
