# The Institute

Established in 1983 under the Societies Registration Act 1860 and the Public Trust Act 1950, as an autonomous body, the Entrepreneurship Development Institute of India (EDI) offers academic opportunities that are intellectually rigorous and extraordinarily diverse. Sponsored by apex financial institutions, namely the IDBI Bank Ltd., IFCI Ltd., ICICI Bank Ltd. and State Bank of India (SBI), we apply innovative teaching methods, competent faculty support, consultancy and quality learning and training materials to create specialists in the fields of development research, micro enterprise development, micro finance, fund raising, corporate social responsibility and social entrepreneurship.

**Mission**: To build a cadre of young development professionals with knowledge, critical perspectives, competencies and skill-sets, required to address the myriad socio-economic issues of development.

For us, development is beyond economic growth and social rights. It is about creating self-sustaining institutions that liberate societies from deprivation traps by increasing productivity, freedom and cooperative interdependence. PGDM-DS is a comprehensive multi-disciplinary course that equips its students with the ability to provide entrepreneurial solutions to social and economic problems, livelihoods for the marginalized sections in the rural and urban areas, corporate social responsibility initiatives and creating social enterprises.

# What makes it different from other management courses?

**PGDM-DS** is an AICTE approved programme offered as a unique programme, which focuses on management, entrepreneurship, development theory and practice.

We concentrate on students who want to become social entrepreneurs or want to join development organizations. The course also provides in-depth knowledge to the students who want to start their own development initiatives. Graduates from any discipline are allowed to join the course. Although the social work and rural management programmes are completely job oriented in nature, PGDM-DS pass-outs garner knowledge and skills to become a social entrepreneur or to start development initiatives on his/her own.

#### Major Takeaways:

- Engage with subjects like gender and poverty, microfinance, human rights, environmental sustainability, livelihood promotion, civil society organisations and more.
- Study core and applied management skills subjects, including strategic management, financial management, human resource management, project management and design, monitoring and evaluation, and research methods for development.
- Field work segment, summer internship and field research segment to augment a practical on-field understanding and exposure to the student's area of interest or forte.

#### **Programme Content**

- The programme spreads over six trimesters of 12-15 weeks each. The content of the programme is designed in such a way that students get exposure to various facets of development work. The courses taught in the programme give insights into practical aspects of development management.
- In PGDM-DS, students have to undergo summer internship for a period of 8 weeks after completion of the third trimester. Students are attached to reputed development organizations across the country to carry out different projects.

#### **Entry Mechanism and Structure**

For admission to PGDM – DS programme, an aspirant has to appear for EDI Entrance Examination conducted at national level. The admission test includes testing the social awareness, logic & reasoning skills, quantitative aptitude, English and Social Entrepreneurial Aptitude Test

Those who clear the written test are called for Personal Interview at different centres.

The personal interview focuses on commitment to the course and training as a source of learning, subject knowledge, communication skill etc.

Performance in both these components are aggregated for final selection for the programme.

Students with valid CAT / MAT / XAT / ATMA / CMAT scores can apply for admission. However, such candidates have to appear for Social Entrepreneurial Aptitude Test on the day of Personal Interview.



## **PEDAGOGY**

We believe in a learner-centric pedagogical system that strikingly blends with highly qualified faculty and up-to-date course content to inspire our students to drive a change towards a world of greater social justice and equality. To ensure a holistic learning process, we recognize the importance of practical exposure along with invaluable academic inputs, by the means of an early rural immersion programme, followed by conducting addition to various field visits, industrial tours. The contemporary classroom learning uses methodologies including audio-visuals, case studies, conceptual discussions and reviews of literature on various topics given as regular assignments, presentations.

#### Preparatory Induction Module - 3 Weeks

An early induction module is conducted for three weeks which facilitates students to develop a deeper understanding of the theoretical and conceptual ideas being developed in the programme. A three-day rural immersion segment is organized in remote villages of Gujarat, with the objective of exposing students to a variety of field settings in order to sensitize them to issues related to development. Field visits form an essential part of learning through practical exposure. Trips to near-by villages, clusters, industries, NGOs and other organisations provide students an opportunity to understand an on-field experience of real time situations, which not only augments their grass-root level knowledge but also contributes in effective learning, creating thinkers and sensitivity to address pressing development issues. The PGDM-DS 14-16 batch visited AMUL to understand cooperative movement, Sabarmati Jail – an institution that encourages livelihood promotion to inmates, the Altruist (NGO) for their 'Dava aur Dua' programme that facilitates mental health professionals to reach out to people who come in search for cure of mental disorders at religious places, Surendranagar cluster to meet the artisans and understand the nitty gritties of the handloom and handicraft sector

#### Field Work Segment – 4 Weeks

The first year includes a project-based field-work segment, which places students in different developmental organizations working in and around Gujarat, that provides a hands-on-ground learning experience of how these organisations work with the communities, by living with the communities and identifying their pursuits and challenges.

#### Summer Internship – 8 Weeks

Once the students decide upon their respective 'Areas of Interest', the institution provides an opportunity to gain professional experience by allowing them to work with firms they prefer. Hence, a compulsory Summer Internship is to be accomplished at the end of the first year, which enables students to apply academic knowledge to real time management problems occurring in various facets of development. The process is facilitated by proper guidance and mentoring of each student. The areas of interest mostly tend to involve fields like Livelihood, Micro-Finance, Water Sanitation and Hygiene, ICT for Development, Education, Social Entrepreneurship, Human Rights and more.

#### Field Research Segment – 3 Weeks

In their second year, students are offered a Course of Independent Study, which provides them an opportunity to gain an in-depth understanding of their areas of interest through a three-week research period. This enables them to explore the intricacies of their respective subject areas and imbibe the necessary aspects of decision making with respect to the same.

# Course inputs

The structure of the curriculum envisages a judicious mix of several learning frameworks including Core Management, Development Theory, Development Action and Experiential learning, which are fostered in the following domain specific subjects.

The courses start with explaining the concepts of economics at the micro and macro level and later specialize in the application of economic issues related to social development and environmental evaluation, under which the subjects include:








#### **Academic Background of Students**

#### **UNESCAP Workshop**






