## BUSINESS ENTREPRENEURSHIP

Trends and practices in business are evolving everyday, and these have necessitated new age entrepreneurs to get armed with entrepreneurial competence before venturing out. The Institute pioneered a full-time entrepreneurship education programme, in 1998, to address this need. The course is now being offered as an AICTE-approved programme entitled, '**Post Graduate Diploma in Management - Business Entrepreneurship**' (PGDM-BE).

## PROGRAMME OBJECTIVES

The objectives of this accelerated, rigorous and application-oriented program are to:

- Develop skills in successfully initiating, expanding and diversifying a business enterprise in new, up-coming areas.
- Develop family business successors as enterprising and knowledgeable owners of the business of their predecessors.
- Develop a cadre of entrepreneurship educators.

## SPECIALISATION STREAMS

In keeping with the objectives, the course offers the following five specializations:

### **New Enterprise Creation (NEC):**

This specialization provides knowledge and develops competencies to start and manage own

business. Students are guided to work on a detailed project report and emerge with a bankable business plan after completion of classroom training.

### **Family Business Management (FBM):**

It aims at developing family business successors into enterprising and knowledgeable owners of the business of their predecessors. Issues, problems and concerns of family businesses are dealt with in greater detail so as to enable the students to come out with an ambitious growth plan.

### **Agri-Entrepreneurship (AE):**

The primary objective of this specialization is to develop agri-preneurs who can operate in the agriculture and food processing sectors, understand their nuances, exploit opportunities in the field and benefit from the latest sector-promoting schemes.

### **Services Management (SM):**

The objective is to facilitate conceptual understanding of the fast emerging services sector and its significance to the new economy. The stream provides an in-depth analysis of the environment that leads to recognition of opportunities in the services sector.

### **Entrepreneurship Education (EE):**

The objective is to prepare a cadre of entrepreneurship educators, researchers and professionals who can contribute to enterprise creation through various interventions and capacity building efforts.





## PEDAGOGY

The interactive nature of learning experience distinguishes the Institute from other institutions. Apart from classroom teaching, the emphasis is on action learning. Business games, simulations, live projects, role plays, interaction with experts, industry visits, case studies, fieldwork and group work combine to create a challenging environment to define problems and find workable solutions.

## FACULTY

The faculty is an ideal mix of resident and visiting faculty with high academic credentials, research base and international exposure. The distinctive research and project consultancy offered by faculty members both in India and abroad ensures that the programme offers content that is contemporary and global in its perspective. Eminent entrepreneurs and professionals visit the campus to teach and share their experiences.

## WHO CAN JOIN ?

Graduates who intend to launch and manage business units, wards/successors of family businesses intending to develop their potential successors, students looking for short term employment before starting their own venture, and

students and professionals wishing to make a career in entrepreneurship education can apply for this course.

## ADMISSION ELIGIBILITY & PROCEDURE

Students must hold a three year Bachelor's Degree, offered by recognised universities in India or abroad with at least 50% marks (45% in case of students from Scheduled Caste (SC), Scheduled Tribe (ST) or Persons with Disability (PWD) category). Students appearing for the final degree examination, can also apply. **Students with relevant work experience will be preferred.**

Students desirous of the admission in this course may have to obtain CAT, MAT or XAT bulletin available from the respective organizations. They also have to apply to EDI by acquiring a Prospectus-cum-Application Form by paying Rs. 1000/- in cash or by sending a Demand Draft, drawn in favour of Entrepreneurship Development Institute of India, payable at Ahmedabad, from EDI Head/Branch or Project Offices.

Students will be shortlisted for the personal interview on the basis of CAT, MAT & XAT scores. However, such candidates will also have to appear for EDI's Entrepreneurial Aptitude Test (EAT).

Besides CAT, MAT & XAT, the Institute reserves the right to select candidates on the basis of its own written test and personal interview.

### FEE STRUCTURE AND SCHEDULE

The fees for the two-year, full-time, residential programme that includes cost of tuition, reading material, library and computer facilities, study visits, board & lodging, laptop/notebook, alumni association membership and students' activities fee is Rs.8,35,000/-. (For fee details see the prospectus)

It also includes caution money deposit of Rs.10,000/-, which does not accrue any interest, and is refundable on successful completion of the course.

Students will also have to bear the medical insurance premium, which is expected to be Rs. 1000/- per year. It is compulsory for each student to get himself/herself insured within 15 days of the

commencement of the programme. EDI will facilitate the process, if need be.

### PLACEMENT

At the end of the first year, students are exposed to applied aspects of managing an enterprise through Summer Internship Placements. The Placement Cell facilitates interaction between students and the industry. Students are placed in different organizations preferably Small and Medium Enterprises (SMEs), as per their specialization / area of interest, for a period of 8-10 weeks after completion of the first year.

On completion of the second year, the Institute will provide limited support in placement to those who wish to work in an enterprise before launching their own, and will also facilitate interaction with Bankers/Financial Institutions to help them start their venture.

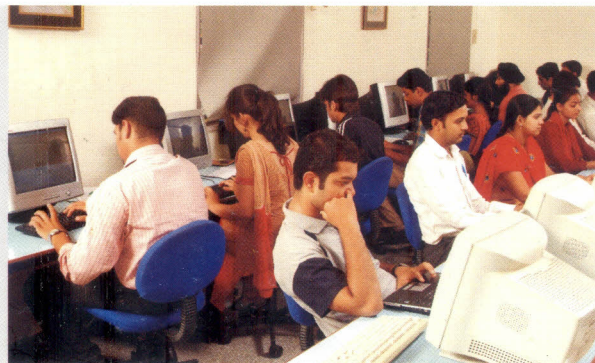

In the international arena, efforts to develop entrepreneurship by way of sharing resources and organising training programmes, have helped EDI earn accolades and support from the World Bank, Commonwealth Secretariat, UNIDO, ILO, FNST, British Council, Ford Foundation, European Union, ASEAN Secretariat and several other renowned agencies.

The Ministry of External Affairs assigned project of setting up Entrepreneurship Development Centers in Cambodia, Lao PDR, Myanmar and Vietnam is progressing in full swing. The already commissioned centres at Lao PDR, Cambodia and Vietnam have started reaping rewards.

In recognition of its international achievements, the United Nations Economic & Social Commission for Asia and Pacific (UN-ESCAP), Bangkok, Thailand, has declared EDI as a 'Center of Excellence'.
