

Shri. R. N. Ravi Hon'ble Governor of Tamil Nadu

Shri Ravindra Narayan Ravi joined the Indian Police Service in 1976 and was allotted the Kerala Cadre. While serving in the Central Bureau of Investigation (CBI), he led several anti-corruption crusades; in the Intelligence Bureau (IB), Ministry of Home Affairs, Government of India, he served largely in terrains gripped in insurgencies. He specialised in the dynamics of human migration in South Asia and worked extensively on the political sociology of border population. Shri Ravi has played crucial roles in conflict resolutions in areas affected with ethnic insurgencies and has brought several armed rebel groups to accept peace. He was the architect of India's international cooperation in counter terrorism and intelligence sharing. After his retirement, he was appointed as the Chairman of Joint Intelligence Committee in the Prime Minister's Office, where, as the Head of the Intelligence Community, he coordinated and guided the agencies to meet the National Security needs of the *Country. He was appointed as the Centre's Interlocutor for the Naga peace talks in* August 2014. Within a short time he could achieve a paradigm shift in the peace process with the rebel armed groups signing agreements for the settlement of the seven decades old separatist insurgency. This ushered peace in Nagaland and the rest of the North-East India. He was appointed as Deputy National Security Advisor in October 2018. He served as the Governor of Nagaland from 01st August 2019 till 16th September 2021. He assumed the office of the Governor of Tamil Nadu on 18th September 2021.
