## Call for Papers

## Submission of Papers

Papers on the themes listed above or any other issue related to the broad theme of the Conference, based on research or practical experience in the field, may be submitted for presentation. Case studies will also be accepted. The authors should adhere the following structure and guidelines:

1. The paper should clearly indicate the title of the paper, a sub-title (if required), name(s) of author(s), e-mail id, address of Institution, city and country;
2. Length of paper: 4000 words, single space, 12 point font size, Times New Roman, Word or RTF File format;
3. Abstract should not exceed 200 words and keywords can be up to 10;
4. APA Style for References;
5. Tables and figures may be incorporated into the text of the paper as close to where they are first referred;
6. Authors are requested to prepare a Powerpoint presentation for the Conference;
7. As the Conference does not offer any provision for interpreters, papers must be written and presented in English language;
8. Avoid using unexplained acronyms, sets of initials and phrases not understandable to international audience;
9. MANLIBNET shall have the first publication rights to papers presented at the Conference. Copyright of papers presented will remain with MANLIBNET;
10. Short CV of the author, on a separate page, to be enclosed with the paper;
11. Paper may be sent to the Organizing Secretary at address given on the last page of the brochure;

All the papers would be put through a process of review by a panel of experts and the accepted papers will be published in the conference proceedings. After evaluation of papers, the Organizing Secretary will communicate to the authors the decision of the Editorial Board, latest by **October 17, 2013**. Correspondence will be made with the principal author and therefore the name, full address, email and phone numbers of the principal author must be clearly indicated.

Poster Presentation: Only accepted papers will be allowed to be presented. Papers may also be accepted for poster presentation. Only abstracts of poster presentations will be included in the Conference proceedings.

Only papers by authors who send their participation confirmation along with the requisite participation fee in advance will be included in the conference proceedings volume and considered to be presented.
