Succession Planning.... An Important Management Task

As we teach in entrepreneurship, 'succession in management' has to be carefully planned or else it could turn into a crisis. Building leaders and successors is important and is the key to any company's sustained performance. Succession planning must begin as a 'process' from the day a new leader takes over. It is the new leader's task to strengthen the critical knowledge base on which an organization stands by ensuring that the talent pool is only strengthened with every passing day.

Succession Planning does not just hold true for commercial enterprises, it has equal relevance for organizations committed to education, training, research or public services. I also feel glad to recollect that over last few years we have added extensively to our infrastructure growth. The campus can claim to have the most modern teaching aids, an auditorium, class rooms and residential facilities. All in all, it was a satisfying journey.

I will be completing my final term on 30th June 2015. The search for new EDI Director began more than 8 months back and I am happy to state that Dr. Sunil Shukla has been selected as the next Director of EDI. He has been Chief Faculty for 8 years and has been associated with the Institute since 1993. I feel happy to say that Dr. Shukla is familiar with every aspect of academic and management related activities of the Institute. He has earned this position out of a national search in which esteemed executives and organization leaders had participated. He would be taking charge from 1st July 2015 with the long-term goal of strengthening every operation of EDI and bringing in new areas of growth. Best of luck Dr. Shukla.

EDI gets its new Director



Dr. Sunil Shukla will be taking over as Director of Entrepreneurship Development Institute of India, Ahmedabad from 1st July 2015. Dr. Shukla, associated with the Institute since 1993, rose to the echelon of Chief Faculty in 2007 and was designated as Director in February 2015, by the high-level Search Committee, constituted for the purpose. Dr. Shukla has over two decades of experience in entrepreneurship education, research and institution-building. Education being his core area, he has been instrumental in accelerating 'entrepreneurship education' at EDI. Presently, he is the Chairperson of Post Graduate Programmes at EDI. The Post Graduate Diploma in Management -Business Entrepreneurship, the first ever PG Programme anchored by him, has been greatly

appreciated for its contemporary curriculum and has won several coveted awards including the United States Association for Small Business and Entrepreneurship (USASBE) award. An avid researcher, he has also ably extended the frontiers of entrepreneurship through research. His research work on 'Review of Entrepreneurship Curricula in Higher Learning Institutions' has helped University Grants Commission, Government of India in developing entrepreneurship curriculum and his work on 'Entry Barriers to Entrepreneurship: As Perceived by Youth', has helped the Ministry of SSI & ARI, Government of India in framing a policy to establish Entrepreneurship and Business Development Centers in Universities.

As a mentor, guide, teacher and trainer he has developed and executed pioneering models in entrepreneurship education and training for students in the bracket of 12 to 22 years, faculty group, executives, bankers, managers, family business successors, administrators and business counsellors. His models have not just generated results in the Indian scenario but have also been implemented and adopted in several countries. He has strengthened entrepreneurship education and research community in several countries such as; USA, Nepal, Malaysia, Laos, Vietnam, China, Thailand, Switzerland, Iran, Brazil and Scotland. Dr. Shukla has extensively worked for the Greater Mekong Subregion (GMS) countries, ensuring that the entrepreneurial potential of the region is unleashed for promotion of development and trade. No wonder, his contribution towards highlighting dimensions of Indian entrepreneurship, on the international entrepreneurship map, has been well recognized. His experience and expertise in the discipline of entrepreneurship, led him to lead the largest and the most prestigious annual study of entrepreneurial dynamics in the world - the *Global Entrepreneurship Monitor (GEM)*, since 2012. Dr. Shukla has been continuing as the national team leader of GEM India since 2012.

Academic, financial and government institutions as also major corporates greatly appreciate his entrepreneurial deliberations, decrees, reasoning, training and mentoring. The corporates that have undergone Dr. Shukla's tailor-made interventions have acknowledged visible increase in their rank and position.

Under his leadership, while EDI's regional offices are also making significant contribution to propagating entrepreneurship across the country, several other organisations and institutions are also directly benefitting from his advisory services and making their impact felt. Dr Shukla is on the Governing Board of 'Centre for Entrepreneurship Development Madhya Pradesh', besides serving as Member of Advisory Committee of Entrepreneurship Education, Department of Science & Technology, Government of India and Academy of Human Resource Development, Ahmedabad. Dr. Shukla is also on the Board of Studies and Advisory Councils of various universities and institutions. He is on the Editorial Advisory Board of 'Journal of Global Entrepreneurship Research', Global Management Review' and on the ASSOCHAM Expert Committee. Earlier, he has served as Member of UGC Entrepreneurship Course Review Committee.

Their march down the aisle of EDI was a perfect testimony to the school of thought that entrepreneurs can be bred and are not just born. The marching academy of achievers represented every bit the dignity of the class of entrepreneurs whom the nation looks up to; they had confidence writ large on their faces; their gait spelt determination- These were the 100 students who had donned the Convocation Caps on 2 May, 2015 at EDI's sprawling campus.

At this 16th Convocation of the '**Post-Graduate Diploma in Management – Business Entrepreneurship**' and '**Post-Graduate Diploma in Management – Development Studies**' 100 students were awarded diplomas – **85** in PGDM-BE (15 in Family Business Management, 70 in New Enterprise Creation) and **15** in PGMD-DS.

The Chief Guest of the function was Dr. Hasmukh Adhia, Secretary, Department of Financial Services,

Ministry of Finance, Govt. of India. Mr. M. S. Raghavan, President – EDI and Chairman and Managing Director – IDBI Bank Ltd. was also present on the occasion.

The function commenced with the welcome address of Dr. Dinesh Awasthi, Director –EDI. Dr. Awasthi introduced the Chief Guest Dr. Hasmukh Adhia and welcomed all to the 16th EDI PG Convocation. He highlighted the landmark contributions of EDI to entrepreneurship and mentioned how EDI had ventured out to widespread entrepreneurship on foreign lands as well. Dr. Awasthi also highlighted the contribution of EDI faculty members to research and to promoting entrepreneurship far and wide. Director congratulated the students of both the programmes.

Shri M. S. Raghavan, President – EDI & CMD – IDBI Bank Ltd., emphasized on the leaps that EDI had



confront obstacles in your path but the key to being successful lies in confronting these challenges, taking some risks and never, ever giving up. You must believe that there is no limit to your achievement."

The Chief Guest of the Convocation awarded medals for best performance to meritorious students and delivered the convocation address.

Chief Guest Dr. Adhia in his convocation address complimented EDI and its Governing Board for conducting these crucial PG programs. He said that EDI has grown into a fine institution for Entrepreneurship in India. He said that EDI is not only the first institute of its kind in the space but also the only one worth reckoning with today. Talking about the growth of India, the Chief Guest said that India is the most exciting place in the world today and that the country is a land of unlimited opportunities. The Chief Guest emphasized on the fact that India is bound to have highest GDP growth in the world because of three Ds – Demography, Democracy and Demand. Dr. Adhia also pointed out towards

unlimited scope in the spheres of agriculture, industry and services. However, he hastened to add that this great scope of the country may get wasted if 'we' do not put our acts together, where he clarified 'we' to comprise the government and the youth of the country. The Chief Guest added that the government has to make sure that the human resource is used properly. He elucidated that development must include contribution of all so that equal opportunities of growth are made available. Giving a glimpse of the Indian business turf, Dr. Adhia mentioned that there are close to 5.77 crores small businesses in the country which create nearly 12 crore employment but these hardly grow and that is because of unavailability of bank credit. The Chief Guest, therefore, stressed that

easy loans must be made available to upcoming entrepreneurs especially the small ones, who several times do not have mortgageable property. Dr. Adhia highlighted the Government's initiative of establishing the Micro Units Development Refinance Agency (Mudra) Bank as a measure to bolster the prospects of first generation entrepreneurs, especially the small ones. The Chief Guest spoke about the need for availability of venture funds and small loaning options to entrepreneurs so that the economy in turn grows. Underlining the need for financial inclusion, Dr. Adhia added that it is important to find more ways to promote such a scenario. To the students, his advice was to use the great opportunity by practicing 'Excellence' and 'Right Attitude'.

Expanding the frontiers

Entrepreneurship has acquired a new face in the current conspicuous and much talked about 'ups and downs' of the market. People have taken to it with a vengeance as an answer to the shrinking job market. Several prestigious management institutions are witnessing a trend wherein students are opting out of the placement process to be on their own. Entrepreneurship courses are also attracting more and more students. And, all these potential entrepreneurs are confident about their well - researched, innovative and creative business models to survive all times-good or not-so-good. If entrepreneurship flourishes during times of economic prosperity, history also bears evidence of emergence of successful enterprises during economic meltdown, too. Therefore, it is only prudent to strengthen people's faith in this discipline by delving into it and researching it to bring out its winning parameters and aspects. The Biennial Conferences on Entrepreneurship at EDI are conducted to probe the different dimensions of, and perspectives on, this discipline.

The Eleventh 3-day Biennial Conference on Entrepreneurship was inaugurated by Prof. Dwijendra Tripathi, (Eminent Business Historian), Kasturbhai Lalbhai Chair Professor of Business History and Entrepreneurship (Emeritus), IIM-Ahmedabad, on February 18th, 2015 at EDI. The Biennial Conference which is being organized since 1994 testifies the Institute's pursuit of excellence and contribution to entrepreneurship education, training and institution building within India and internationally.

The conference began with the welcome address of Dr. Dinesh Awasthi, Director – EDI. Dr. Awasthi

traced the genesis of the Biennial Conferences and informed all that this core activity of the Institute had been initiated by Dr. Dwijendra Tripathi in 1994. He added that the Conference had broadened the frontiers of entrepreneurship which is significant to create and develop a self-sustaining, wealth generating productive entity.

Dr. Dwijendra Tripathi inaugurated the conference and talked about the evolution of entrepreneurship into a promising yet challenging discipline. Dr. Tripathi began by stating how Entrepreneurship as a concept had originated in the discipline of Economics to explain the locus and manifestations of economic aspirations of which a business is a major part.

He added that economic development emerged as a major social concern after the Second World War but these were less concerned with constitutes of entrepreneurship and more with what makes an entrepreneur; the distinguishing traits of entrepreneurs, and how to develop these traits. "In the process, entrepreneur and entrepreneurship came out of the secluded corners of Economics books and became a more commonplace phenomenon, encompassing any innovative, purposive activity, not necessarily aiming at tangible monetary gains," informed Dr. Tripathi. "The terms entrepreneur and entrepreneurship," he added, "lost the technical connotation and assumed a more generic meaning to connote uncommon accomplishments in any sphere of human activity."

However, coming on to the present context, Dr. Tripathi said that in the present times, however, entrepreneurship, as a concept, has a vastly different and wider connotation than it had, a few decades ago. Elaborating on this, he said, 'Innovation' does not generate the same awesome feeling anymore as it did when Joseph Schumpeter placed it at the heart of an

entrepreneurial act during the mid-1930s. 'Achievement Motivation', he added, caused some sort of mild sensation when Psychologist David McClleland propounded it in the early 1960s but the same does not carry the same significance today.

"All these developments have added to the challenges of the entrepreneurship researcher. The task of advancing the frontiers of our understanding demands analytical documentation of new initiatives emerging all around us in all walks of life in the wake of renewed emphasis on economic and social rejuvenation," emphasized Dr. Tripathi. One of the most exciting developments of the last two decades that Dr. Tripathi highlighted was the increasing number of young persons moving away from salaried jobs and taking to self-employment and the increasing number of management graduates setting up their own enterprises, disregarding the risk involved. Just until yesterday, he said, "they

preferred well paid salaried jobs with perks and prestige. The entry of women in the realm of self-employment is a new phenomenon. Equally exciting the rise of nong o v e r n m e n t a l organizations (NGO), f o c u s i n g o n laudable social causes".

These changes and thus, documentations may inspire others to take the plunge and help prospective entrepreneurs to avoid pitfalls, he said. However, he added that a single factor does not create the same impact on every individual. Arguing this, he stated, "This is because the appreciation of the environment on the part of an individual is to a large extent determined by his personal values which in turn are conditioned by factors specific to him, such as; family affiliation and upbringing, common nature and education, training, social references and so on."

Dr. Tripathi concluded by emphasizing on the significance of documentation, despite challenges and disparities. He pointed out that documentations informed by such a comprehensive framework may reveal many new facets of entrepreneurial behaviour.

This Conference witnessed submission of 350 papers out of which 144 were selected. The participants not just represented India but also Algeria, Bangladesh, Ethiopia, Germany, Indonesia, Jordon, Malaysia, Mexico, Nigeria, Poland, Serbia, Sultanate of Oman, Sweden, UK, USA, Uzbekistan and Zimbabwe. The papers covered the themes of Entrepreneurship in the SME Sector and Micro Enterprises, Entrepreneurship Education, Innovation, Incubation & Entrepreneurship, Social Entrepreneurship, Entrepreneurship & Family Enterprise, Women Entrepreneurship & Family Enterprise, Sectoral Entrepreneurship (e.g. Agripreneurship, Edupreneurship, Tourism Entrepreneurship, Services Management, etc.)

The Conference provided a platform for researchers, academics, planners and policy-makers to share their work, ideas and concerns and brainstorm strategies for entrepreneurship development.

Promoting high-tech science and technology based entrepreneurship holds potential, and needs to be encouraged to ensure that India remains at the forefront of global tech-business leadership; more so, as India has the 5th largest pool of scientific manpower with enormous potential, backed by demographic dividends. Hence, the Centre for Policy Research in Science & Technology Entrepreneurship set up at EDI, under the aegis of Department of Science and Technology, Govt. of India, works with the mandate of promoting innovation-driven S&T Entrepreneurship; strengthening policy research mechanism and influencing policy formulation through advocacy. The centre activities are steered under the leadership of Mr. S.B. Sareen.

Over the past months, the centre undertook significant research work and studies to promote

Studies that were successfully undertaken, were released on National Technology Day, 11 May, 2015 at the hands of Dr. Harsh Vardhan, Hon'ble Union Minister of Science & Technology. These include:

• Study on Problems and Issues Faced by Hi-Tech Entrepreneurs in Launching, Managing and Growth of their Ventures: Some Policy Options - This study attempted to underscore the dynamics of formation, survival and growth of S&T entrepreneurs, and the impact of policy on their business/strategies. The study was conducted by Dr. Dinesh Awasthi, Director, EDI; Dr. Archana Dholakia, Distinguished Visiting Professor; Mr. Bipin Shah, Sr. Faculty and Dr. Jignasu Yagnik, Sr. Faculty.

The Department of Science and Technology, Govt. of India, has taken several initiatives over the last three decades to foster the emergence and growth of hi-tech innovations in India. A review of prevailing literature leaves much to be desired in the sphere of policy frame and impact of policies on emergence, operations and growth of hi-tech enterprises. It is important to understand the needs of hi-tech entrepreneurs and the issues they face in setting up and managing their ventures. Also, it was felt that one needs to understand the growth pains faced by hi-tech entrepreneurs and the measures they adopt to manage growth. To probe these unexplored areas, EDI undertook this study.

The study covers DST supported hi-tech entrepreneurs having emerged with support of STEPs, TBIs, TDB and iEDCs. The ventures in operation for at least 3 years, have been covered in the study. This being a national study, attempt was made to cover all the regions of the country, viz. North, South, East and West.


130 DST supported and 35 non-DST supported hi-tech entrepreneurs, besides 25 other stakeholders from support system feature in the study. • 25 Cases on Impact Making S&T Entrepreneurs Promoted/Supported by DST

Under this DST supported initiative, the Institute documented the travails and triumphs of S&T driven entrepreneurs for wider dissemination among youth in various engineering, technology and management institutions, besides R&D laboratories. The document was edited by Dr. Dinesh Awasthi, Director-EDI and Dr. Rajiv Joshi, Asso. Sr. Faculty.

This documentation highlights some of the finest innovations done by Indian science and technology entrepreneurs. It showcases how they undertook all this despite many constraints and against all odds. These stories highlight a culture of innovation and spirit of creating things that has changed India; and has potential to change the world. The stories included in this book would motivate the coming generations of students in general, and technology students in specific, to consider entrepreneurship as a career. It would act as a great motivation tool.

The young readers can visualize the process of entrepreneurship. The readers would be able to understand the rhythms of startups: identifying a need, recognizing an opportunity, creating a vision for the enterprise, developing a plan for launching the enterprise, building a support network, taking actions, mitigating risk, adapting to challenges, evaluating progress, making adjustments, and repeating this process.

In addition, to fill the gap of paucity of information and to measure the level of entrepreneurial activities by geographies, products, etc. an integrated online database has also been developed. This initiative will help promote insights into the trends in S&T enterprise creation in the country.

Children and youth have to be strategically inducted into a high performing environment by infusing in them the winning qualities that not just see them through the highs and lows in life but also enhance their professional life at every critical juncture. But, the rider that goes with this requirement is that the intervention must take place at the 'right time'. Summer Camp on Entrepreneurial Adventures for Youth, which EDI has been organizing over last 20 years is a platform for youths to realise their hidden potential, add to their strengths and capabilities, and hone these in a way that these become their most endearing traits.

This year, in the 27th National Camp on Entrepreneurial Adventures for Youth, 56 youths from 22 cities of India, discovered how proper direction, training and counselling could inculcate self-sustaining, deep rooted inclination for growth in an individual. The camp focused on entrepreneurial motivation development exercises, evaluation and development of entrepreneurial traits and competencies, visits of institutions of repute to analyze the process of creation, exposure to potential opportunities existing in industry and other occupations, self-assessment through specially designed psychological test, career and psychological counselling and formal and informal interaction with successful entrepreneurs.

Simulation exercises to impart an understanding on issues such as; problem solving, decision making, team building, creativity and related themes were also focused upon.

And, as 18 years old Arinjit Das from Jaipur, puts it, "I feel like a new person. I don't think I would ever have such an experience again in my life. Learning through games and exercises was a strategy that Shri P.K. Laheri stressed on the importance of continuously interacting with youths to understand the gaps between generations and to equip them in a manner that they become future ready. Shri Laheri appreciated the way youth of today are conscious about using various sources to educate and inform themselves and advised them to use all their information base to stay away from routine in order to achieve something extraordinary. The Chief Guest called 'entrepreneurs' as the group of people who think different and thus move away from the ordinary to explore the extraordinary. He advised the participants to follow the path of entrepreneurship, urging them to give wings to their potential. He motivated the youth by reminding them of their tremendous store of teen energy which he said they must channelize in the right direction and in this, the Chief Guest appreciated the work which EDI was doing. A few significant points that the Chief Guest listed for the students were;

- Do something offbeat
- Aim high-be ambitious
- Have an attitude of adaptability and flexibility
- Have an open mind
- Contribute to knowledge creation
- Cope with uncertainties and learn to overcome stress
- Learn throughout your life

perfectly gave us the learning, and the knowledge that I have gained as a result, will remain with me all through my life."

Youths even got to experience the spirit of enterprise. Based on the guidance of EDI experts and their own creativity, they even set up their small enterprises, and earned money by working strictly within EDI campus. Ask them about this and they say smiling, "We now understand what hard earned money actually means." According to Dr. Sunila Shukla, Director Designate and Chief Faculty-EDI, "Entrepreneurship as a career option has always interested individuals but at the same time it has also intimidated individuals. This 'fear of failure' is merely perceived on account of age old untruths associated with the discipline. The idea of these camps emanated only to address this mindset. It was felt that a special module should be designed to inculcate entrepreneurial traits in children and youth - this age considered apt to mould them into thinking about entrepreneurship as a natural career option. I would say the camps focus on inculcating winning attributes, which so characterize an entrepreneur, in these youngsters at a time when they are so receptive."

The participants vowed to never do away with the learning received and looked forward to implementing this in their lives. They promised to hone their skills at every level of life, be a constant learner and never be bogged down by crises.

The Institute also conducted the 26th National Summer Camp on Entrepreneurial Stimulation for Children in the age group of 12 to 16 years during 3-8 May, 2015. 92 Children from across the country participated. Mental gyms, motivation and creativity exercises, puzzles, value education, presentations and learning through success stories and meetings with achievers were the highlights of the camp. The achievers who were invited to interact with the participants were Dr. Prutha Desai, an epitome of courage-she survived the oddities of the 2001 Gujarat Earthquake, struggled without ever losing hope, to become a doctor, Mr. Nirvesh Dave, runner up of Indian Idol Junior, Ms. Darshita Shah, an award winner in the social sector and Ms. Nilambari Solanki, Owner-Bookman.

And, as we ponder over the magic that these camps imbue in young champs, we recall the words of Dr. Pankaj Bharti, the Camp Leader, "The camps succeeded in instilling a 'never say die' attitude in these youngsters. I believe such an attitude only comes from tremendous confidence and I am glad that we could develop this in them." The valediction function of this Camp was organized on 8 May, 2015 at EDI Campus. The Chief Guest was Shri Rushad Ginwala noted Restaurateur (Creator of Mirch Masala, Tomatoes and the like). Sharing the dais with him were; Dr. Dinesh Awasthi, Director-EDI, Dr. Sunil Shukla-Chief Faculty, Dr. Pankaj Bharti, Camp Leader and Dr. B.B. Siddiqui, Distinguished Faculty Member.

Who can better influence students and orient them towards all things 'new' than their teachers whom they revere and trust as well wishers. A good teacher –leader can intertwine the fragmented dreams of students with focused goals, thus, motivating them and imparting them a direction to pace on.

Application-orientedness of our education is being continuously stressed upon both by the policy makers and the faculty group. The faculty group, in particular, across India has endorsed the significance of application-oriented competencies to enhance 'Career Value' of their students. Entrepreneurship is one area which has emerged as a promising option in this sphere. To a large extent, the success of an entrepreneur depends upon his/her skill level, people skills and sensitivity to the market and the environment around. With the growing significance of entrepreneurship education, the faculty group has also taken the onus of imparting extensive learning in this area to stimulate critical thinking of students and bolster their entrepreneurial bent of mind. Over the last years, EDI has organized several Faculty Development Programmes (FDPs) to develop a cadre of resource persons with contemporary knowledge and skills to guide and motivate students to take up entrepreneurship as a career. During 16-28 March, 2015, EDI organized an AICTE sponsored Faculty Development Programme in Entrepreneurship. 50 participants from 10 states such as; Gujarat, Maharashtra, Tamil Nadu, Karnataka, Rajasthan, Assam, West Bengal, Uttar Pradesh, Telangana and Kerala participated in this programme.

The main objective of the programme was to expose the participating faculty members to the comprehensive entrepreneurship development process and equip them to coordinate or organize entrepreneurship related activities in their educational institutes.

Training approach was based on adult learning principles/experiential learning with focus on lecturecum-discussions, case studies, role plays, simulation exercises, curriculum development, opportunity guidance and interaction with successful entrepreneurs for practical insights. Study visits to institutions and enterprises introduced them to key aspects of the discipline and brought them face-toface with ways and means of dealing with crises. Such an exposure, expressed the participants, will enable them to handle the intriguing queries and anxieties of their pupils.

The 13-day programme concluded on 28 March 2015. Dr. Dinesh Awasthi, Director-EDI awarded certificates to the participants and delivered the valedictory address. Dr. Awasthi congratulated the participants and stated, "Today's youth is an aware lot with a strong mind and sharp decision making power. However, they need to be convinced about entrepreneurship, its charms and benefits. We had, therefore, carefully designed the curriculum of this programme to ensure that the participating faculty group not just received knowledge but also developed a strong conviction in 'Entrepreneurship' to be able to transfer this on to their students." Dr. Sunil Shukla, Chief Faculty and Programme Coordinator highlighted the growing degree of work which was going on in the sphere of entrepreneurship and the increasing thrust on policy formulation, literature development, curriculum design, training programmes and human resource development in the area. He mentioned that in line with these interventions Faculty Development Programme is a useful course to strengthen the discipline by creating cadres of competent resource persons who could act as messiahs to advance the frontiers of entrepreneurship.

The programme not just probed the various dimensions of entrepreneurship but focussed on knowledge which was guided from the perspective of variables like; Gender, Age, Literacy, Family Background, Business Opportunity, Caste and the like. The faculty members also participated in extensive brainstorming to bring diverse ideas on a particular topic to a convergence. All in all, the programme was well received and will generate a multiplier effect on entrepreneurship development.

Diversifying and Deepening Skills.... Across the Globe

Internationally the term entrepreneurship is endorsed for the kind of competencies and traits that are associated with it, and the achievements that this discipline guarantees. Developing countries are especially keen on acquainting their professionals - be it government officers, NGO functionaries or entrepreneurs- on entrepreneurial skills that always make themselves apparent with the success that accompanies them.

Every year, EDI conducts programmes for professionals from developing nations on various aspects of entrepreneurship and small and medium enterprises. These are conducted with the sponsorship support of Indian Technical and Economic Cooperation, Ministry of External Affairs, Govt. of India.

A glimpse into the programmes conducted over the last few months:

Entrepreneurial Management

Today, as organizations grow, they face several challenges in the changing environment. The conventional wisdom, pyramid structure and organizational hierarchy are becoming the things of the past. Alliances and Collaborations are giving way to competition.

If complexities and challenges best describe today's environment, new opportunities have also surfaced and wait to be tapped. In such a scenario, management practices and organizational functions need a fresh approach so that these promising opportunities could be seized and explored optimally. This has become the biggest challenge in front of organizations today. Evidences suggest that an effective solution lies in the practice of promoting and harnessing entrepreneurial management which permeates at all levels of an organization.

Six-week international training programme on 'Entrepreneurial Management' was organized during 23 February- 3 April, 2015. 29 participants from 23 countries such as; Afghanistan, Egypt, Gautemala, Ivory Coast, Kyrgyzstan, Libya, Madagascar, Malaysia, Mongolia, Nepal, Niger, Peru, Poland, Serbia, Thailand, Tunisia, Vietnam, Botswana, Ghana, Malawi, Nigeria, South Africa and Zimbabwe, benefitted from the programme. The main objective of the programme was to help participants create an enabling organizational framework and put into practice the principles of entrepreneurial management that fosters entrepreneurial culture and practices at all levels of the organization.

According to Programme Director, Dr. Rajiv Joshi, "Entrepreneurial Management is a programme of today as the organizations of the present time need executives with skills that help obtain the maximum from the existing resources." The programme, he informed, enables the participants to understand contemporary management and entrepreneurial practices and principles to float a winning work environment.

The participants also felt that they had acquired upto-date knowledge on current trends in organizational strategies and working styles and said that this would result in better alignment of individual and organizational goals.

Sustainable Livelihoods and Mainstreaming with Market

The majority of the world's underprivileged lives in marginalized areas, largely dependent on natural resources and environment for their livelihoods. In many areas of the world, particularly in sub-Saharan Africa, the number of people living in absolute poverty is rising. These people also lack direction and resources to claim their rights to a fulfilling life.

The condition needs to be addressed in a way to ensure more and more livelihood opportunities every year. Given the magnitude of the problem, and the dearth of resources for livelihood promotion, the task of promoting livelihoods for the poor becomes all the more urgent. It calls for organizations to use their resources optimally to achieve the maximum. There has to be a brigade of people that understands the changing dimensions of livelihood promotion to align their measures with the changes taking place across the world in terms of opportunities, markets and options.

The eight-week international training programme on 'Sustainable Livelihoods and Mainstreaming with Market' was hence conducted during 23 February - 17 April, 2015 to impart a sound conceptual foundation and pragmatic understanding in sustainable livelihood to professionals and hone their skills to design, strategize, implement and articulate systems approach in this area. 32 participants from 17 countries such as; South Africa, Kyrgyzstan, Tonga, Tanzania, Myanmar, Kenya, Cambodia, Syria, Lesotho, Ivory Coast, Fiji, Malaysia, Uganda, Mauritius, Maldives, Guyana and Poland participated in this programme. Dr. Manoj Mishra was happy with the results of the programme and stated that the participants had acquired up-to-date skills in successfully undertaking project management for livelihood related programmes and thus, in imparting a better life to millions around".

Empowering Women through Entrepreneurship Development

Women constitute around one-quarter to one-third of the total business population and in manufacturing they make for about one third of the global labour force. However, despite their important contributions to socio-economic development, much remains to be done in terms of harnessing their potential to the hilt. Women come across certain typical barriers that inhibit them from playing a major role on the entrepreneurial landscape. A need was, therefore, felt to bring about a change in scenario by imparting knowledge, skills and inputs to bring about a positive attitude for overall development of women as business leaders. It has been experimentally tested and proved that entrepreneurial qualities, skills, attitudes and perceptions can be instilled and developed through a judicious mix of training interventions, counselling and guidance. This six-week program primarily focused at creating a cadre of resource persons who were adequately sensitised towards the concerns of women entrepreneurs. They were imparted an



understanding on new tools and methodologies to enhance entrepreneurial capacities in women and to give them an enabling environment.

This international programme was represented by consultants, academicians, trainers, potential and existing women entrepreneurs, bankers, executives and NGO functionaries from 24 countries such as; Argentina, Bangladesh, Cambodia, Chile, Guyana, Ivory Coast, Kyrgyztan, Madagascar, Malaysia, Maldives, Mongolia, Philippines, Thailand, Togo, Tunisia, Vietnam, Ghana, Kenya, Malawi, South Africa, Swaziland, Tanzania, Uganda and Zimbabwe. The duration of the programme was from February 23 to April 03, 2015. The modules were structured around Women Empowerment, Motivation & Leadership, Business Opportunity Identification, Business Sensitivity Analysis and Venture Financing and Institutional Support System. The programme was well received and the participants said to have understood the existing gaps in promoting women as entrepreneurs and the strategies that could enhance the incidence of women entrepreneurship

Programme Director Mr. P. Ganesh felt that more such programmes should be conducted so that the environ becomes more accepting to women excelling as entrepreneurs and the economy benefits with this accelerated pace of New Enterprise Creation.

Entrepreneurship Education to Strengthen Emerging Economies

Emerging economies abound in resources but for these to generate benefits, it is important to align them with entrepreneurial knowledge, skills and attitude that lead to their proper channelization. Entrepreneurial education has emerged as a promising discipline to orient entrepreneurial minds to New Enterprise Creation. The trained brigade then harnesses resources and implements their mantras on business creation and management to achieve success. For them business does not come as a last resort but is a preferred career.

EDI, organized an international training programme on 'Entrepreneurship Education to Strengthen Emerging Economies' during 23 February–3 April,

2015 for 20 resource persons from 14 countries including; Sudan, Ethiopia, Peru, Madagascar, South Africa, Ghana, Ivory Coast, Brazil, Tunisia, Russia, Afghanistan, Laos, Zambia and Mongolia. The objective was to impart an indepth understanding on formulating customized and need based entrepreneurship education policies, strategies and programmes in their respective countries. The programme also focussed on enabling participants to create resilient and competent early-stage entrepreneurs, groom family business successors, women entrepreneurs and nurture intrapreneurs. The participants also drew learnings on successfully initiating and conducting programmes on entrepreneurship to create a conducive environment where entrepreneurship germinates and grows. An important aspect of the programme was its focus on guiding participants to develop business incubators so that students could get support in developing bankable business plans and start-ups. Dr. Sunil Shukla, Programme Director stated that the programme was a great step towards infusing entrepreneurial traits in individuals so that nations across the globe stand on the premise of entrepreneurship. The programme was co-ordinated by Dr. Amit Kumar Dwivedi, Faculty-EDI.

Promoting Innovation & Entrepreneurship through Incubation

The present day economy beckons knowledge-based ventures by virtue of standing on the premise of innovation and entrepreneurship. Increased awareness about this, especially in developing nations, has led policy makers and other stakeholders to view business incubation as a necessary tool to promote dynamic, innovation driven enterprises. Business Incubators have, therefore, become widespread and are definitely pointing towards an era of competitive, forward looking enterprises. In order to create a cadre of officers, fully conversant with the process of business incubation, the Institute, with professional support from the Asia Pacific Incubator Network, Coimbatore and the Dept. of Science and Technology, Govt. of India, organized a programme during January 5 to February 13, 2015 for 26 officials from 14 different countries.

The main objective of the programme was to enable incubation managers accept challenges of modern day business and introduce changes that address all functional areas and impart a forward push to the venture. The programme addressed problems in the areas of entrepreneurial ecosystem, sources of funding, business models and strategies to obtain financial leverage for the incubated business. The participants even visited some of the renowned incubators across the country to understand the process of initiating, planning and implementing business incubation activities. Highlighting the importance of incubators, Programme Director, Mr. S. B. Sareen said that they are an essential component of a conducive entrepreneurship eco system. He stated that 'innovation' will receive a boost under an incubator supported business environment.

Cluster Development Executives (CDEs) Programme

Cluster Development Programme (CDP) has become one of the most effective instruments to ensure survival and growth of micro, small and medium enterprises (MSMEs). Experiences show that successful implementation of Cluster Development Programmes could help MSMEs significantly improve their business performance, adopt appropriate technologies, improve quality and productivity, increase turnover and export, improve HR and management efficiency. Initiatives under Cluster Development Programme could help cluster firms go for value addition, product customization, brand building, improvement in marketing and export performance. This ensures their holistic development and contributes towards Local Economic Development (LED). These efforts are needed to enhance competitiveness of the cluster MSMEs and make them stand tall in the globalized economy.

Cluster Development Executives (CDEs), can streamline development initiative in the desired manner. This international programme conducted during January 5 – February 13, 2015 aimed at creating a cadre of CDEs by improving knowledge and skills of participants so as to enable them to successfully implement a Cluster Development Programme. 27 participants from 15 countries participated in the programme.

Programme Director, Dr. Sanjay Pal said that clusters were gaining huge significance across the world and hence this programme, and more of this nature, could greatly impact economies the world over. The programme covered all aspects of clusters and their significance and sought to impart maximum learning to the participants, he explained. Listing the areas focused upon, he said that, dynamics of MSMEs working in clusters, role of trust building and CDEs, consortium approach for ensuring holistic business performance, role of business development services (BDS), private-public-partnership (PPP) mode in developing common facility centres (CFC) and improving global competitiveness of the cluster firms/MSMEs were topics which were covered and added to the perspectives of the participants.

The participants appreciated various modules of the programme, and felt confident about making meaningful contribution to the economic growth of their respective countries. Their action plans indicated that they had developed rich insights into addressing the development issues in clusters, to attain all round growth.

Agri-Entrepreneurship & Supply Chain Management

Agri Business refers to various businesses involved in food production, including farming and contract farming, supply of seeds, fertilizers, agro-chemicals, farm machinery, wholesale and distribution, processing, marketing, and retail sales. Agriculture has evolved into agribusiness and has become a vast and complex system that reaches far beyond the farm to include all those who are involved in bringing food and fiber to consumers. It represents:

(1) Agricultural input sector; (2) Production sector and (3) Processing-manufacturing sector

The success of agribusiness is dependent on proper planning, research, location, layout and size, climatic

conditions, etc. The rising food prices, increasing unemployment in rural areas, wastage of food grains due to lack of storage and demand for nutritious food etc. create tremendous opportunities for agriculture entrepreneurs (particularly in developing nations) across the world. Agriculture entrepreneurs will be useful in transforming rural communities into a resource for economic development. Market liberalization and increasing consumer demand in both developing and developed countries offer attractive opportunities for agricultural producers/traders. Trade in fishery, dairy, fruit & vegetables and organic products extend altogether new options for businesses. This presents major challenges in the form of state-of-the-art technologies and infrastructure for supply chain. Through supply chains, producers in developing and emerging economies can access market information and knowledge to hone their value-added services to both domestic and international customers.

This international programme conducted during January 5 - February 13, 2015 with 20 participants from 17 countries focused on sharpening knowledge on emerging opportunities in agri-business, aspects involved in commodity market & supply chain management, and cultivating an entrepreneurial attitude among participants. The participants were encouraged to innovate by combining knowledge and skills to develop solutions to economic issues in the food and fibre system.

Programme Director Mr. Satya Acharya was happy with the response of participants and hoped for connected agrarian societies with increasing number of agri-based business ventures.

Manifold Entrepreneurship Efforts to Make an Impact

Across the country, EDI has been conducting programmes to generate maximum positive response towards entrepreneurship. EDI innovation hones surgeons' cutting edge

Ahmedabad: The danger of contracting an infection from blunt surgical instruments has been reduced. Enhancing the cutting-edge of these tools is Entrepreneurship Development Institute of India (EDI) with its innovation.

Several surgical instruments used here are too blunt, resulting in botched surgeries and causing great trauma to patients. This has been forcing Indian doctors to import surgical instruments at high cost. In such a scenario, technocrats and scientists led by senior faculty K K Shaw of EDI's International Centre for Cluster Competitiveness, Growth and Technology developed a mechanism to render slag-free surgical instruments and have secured a



patent for it.

"Surgical scissors, knives, forceps, needle holders, clamps and chisels are made from hardened grades of stainless steel. Odd configurations of parts are generally forged which results in forging scale on the exterior of these components. The scale is removed by a mechanical shot blasting process which has several limitations and inadequacies. This demands an alternative method to remove forging scale from stainless steel," Shaw said.

He said his process uses a liquid at a high temperature that can go into cavities without diffusing into the forged components. The components are treated with an acidic solution to provide an excellent surface finish.

Oral cancer surgeon Dr Kaustubh Patel said: "Lives can be at risk and precision of surgery is jeopardized if surgical tools are blunt. This can also cause trauma to the surrounding tissue. Inflammatory response as a result of blunt instruments can delay the healing process."

Shaw said his invention can also be used for making several automobile components, parts of machine tools, food processing and pharmaceutical machines from iron and alloy steel.




Entrepreneurship Education Conclave

Clusters Make a Clarion Call to Development

Under the cluster development program of Governement of Gujarat, EDI is implementing Cluster Development Project (2 years : March 2015 – Feb 2017) at the following four cluster locations in Gujarat:

Walking on a Tightrope

Mr. Viral Pandya PGDBEM 1998-1999

Viral Pandya, a shy, introvert student from a middle class Gujarati service family from Baroda inspired by his friends' business achievements decided to plunge into business. Eager to commence business but owing to his service family background Viral did not have knowledge and skills for creating and managing a business enterprise. And, just around this time, when Viral came across a newspaper advertisement on PGDBEM Programme at EDI, he instantly got interested.

As Viral puts it, "During the one year spent at EDI I had a good exposure to varied aspects of setting up and nurturing a business enterprise. Industry-academia interactions deeply motivated me to take the risk and plunge into business. I learned to think big and aim high in life. The curriculum enabled me to unleash my hidden potential. At EDI, I learned the niceties of self-analysis, which I believe is a critical factor for any individual to emerge successful in life! EDI enabled me to identify my strengths and weaknesses. Since then I have leveraged my strengths and tried to overcome my weaknesses or at least avoid moving into those areas where I know I am weak."

With an aim of acquiring technical experience in insulation, Viral joined M/s Lloyd Insulations (India) Ltd. as a project supervisor and acquired rich technical experience in hot and cold insulation piping, equipment towers, reformer ducting, T.G. set and reformer pigtails with calcium silicate blocks. At M/s. Navbharat Insulation & Engineering Company, he led a team of five site supervisors, an accountant and around 200 workers for insulation work worth around Rs. 1.5 crores at five plants of Reliance Petroleum Limited.

Having gained such work experience and acquired entrepreneurial training at EDI, he eventually initiated Rudra Engineering, a thermal insulation business in August 1999. Viral's precision to these three vital aspects of insulation – quality, safety and time frame, offered him good word of mouth publicity for his insulation services. Delivering value to his customers by strictly adhering to the quality and safety standards and honouring the delivery schedules he developed a strong client base in Gujarat. Thinking that a backward integration into 'poly urethane foam', a key raw material used for insulation, would ensure cost reduction, quality control, timely availability of the raw material and push up margins, in April 2008, Viral established Rudra Insulation for backward integration.

Tirelessly nurturing his baby enterprises with sincerity, commitment and hard work, Viral, eventually expanded to Chhattisgarh and steered his ventures towards growth.



Eco Cell Makes a Progressive Move

Tapan Ghosh PGDMN 2001-2002

After completing Post Graduate Diploma in Management of NGOs (PGDMN) programme at EDI in 2002, Tapan Ghosh joined Kutch Nav Nirman Abhiyan (KNNA) where he worked for natural resource management, livelihood and agriculture and allied programmes. However, Tapan wanted to get into something more meaningful he wanted to give back to society. In February 2008, while still at KNNA Tapan along with his brother Amit Ghosh initiated *Eco Cell, a partnership firm offering consulting and facilitation services for date cultivation & allied services to farmers in Kutch.* Government offered subsidy for promoting horticulture but farmers were unable to avail it as they were either unaware about it or found it to be a time consuming, cumbersome process marked by formal procedures and requirements. *Eco Cell aimed to fulfill this gap. Tapan remarked: "Our services depend upon farmers' needs.* Some farmers may need only plant procurement while some other may demand our entire package right from Date Cultivation Project Formulation, Financial Linkages, Application for Government Subsidy (State & Central) and Project Implementation along with backward and forward market linkages."


Amit states: "Farmers normally grow more than one crop on their farm lands. Usually they cultivate cotton, castor or similar other crops across major area of their farms with date palm on farm borders. Moreover, they do not have the competence to develop market linkages and accept whatever is offered for their farm produce. Eco Cell's consulting cum facilitation services has enabled farmers in gaining good returns through exclusive date cultivation across their farm lands." *Initially, Eco Cell focused only on large farmers under Central Government Horticulture Scheme covering those with more than 10 acres of land. However, in 2013 it extended its services to Small and Marginal Farmers with less than 5 acres of land under State Government Horticulture Subsidy scheme.* Eco Cell had served about 450 small, marginal and large farmers of Kutch.

In 2014, Tapan and Amit also ventured into Eco Moves, an E-Rickshaw assembling unit in Kutch. Tapan says, "At present Eco Moves offers Passengers and Loader Rickshaws". In addition to commuting, an E-Rickshaw can also be deployed to transport varied goods and can also serve as a waste collection vehicle, particularly in highly congested areas where normal large waste collection vehicles are difficult to use.

With nearly 18 years of experience, mainly into development sector along with a brief stint in the corporate world, Tapan has worked with Lok *Prerna, Centre for Environment Education (CEE), Ashapura Foundation, SGS India Limited, Team Lease as the State Head for Jharkhand & Bihar, Gujarat Livelihood Promotion Company (GLPC) as the District Livelihood Manager for Kutch.*

Reflecting over his days as a Post Graduate student at EDI, Tapan says, "When I joined EDI, I was totally an introvert; the PGDMN programme enabled me to open up. EDI enabled me to identify my talent and apply it productively. It gave me some good friends and mentors who were very supportive.

New GEM India Consortium

Global Entrepreneurship Monitor (GEM) Survey is the largest annual study of entrepreneurial dynamics in the world. GEM was conceived in 1997. IIM-Bangalore had anchored the study in India in 2001. After twelve years, i.e. in 2012, India participated again in the study to probe the nature and level of entrepreneurship among different strata of the economy, in India. The 2012 GEM India Consortium comprised three prestigious National Institutions wherein EDI played the role of Lead Institution with Dr. Sunil Shukla, Director Designate, leading the team. EDI successfully anchored the National Expert Survey and the findings were included in the GEM Global Report 2012, 2013 and 2014.

On April 11, 2015, the new GEM India Consortium was formed and a Memorandum of Understanding (MoU) was signed to this effect at EDI. The three Institutions that comprise the Consortium are; Entrepreneurship Development Institute of India (Ahmedabad), Centre for Entrepreneurship Development Madhya Pradesh (Bhopal) and Jammu & Kashmir Entrepreneurship Development Institute (Srinagar). With EDI as the lead Institute, Dr. Sunil Shukla will continue to play pivotal role as leader, thus ensuring that the GEM India Research is completed over the next three years. A team of seven researchers has been constituted to take the onus of this task.

The GEM survey has proved immensely useful in providing data for researchers; knowledge on global entrepreneurship for educators and practitioners and information to guide policy makers in formulating effective and targeted policies and programs.
