

.....And the Concept of Entrepreneurship Was Born

The entrepreneurship development approach got a formal recognition in January, 1970. Although this was a period when people believed entrepreneurship to be an excuse for non-performance, a few did see this as an answer to aid employment and economic growth of the country.

It's been a story since - a story that unfolded the potential of an amazing concept.

In 1969, the Gujarat Industrial and Investment Corporation (GIIC) and Gujarat Industrial Development Corporation (GIDC)

jointly floated their liberal credit scheme, 'The Technician Scheme' that offered 100% finance to technocrats who could not afford seed money but had business ideas. Several technocrats and employees with little education including turners, fitters, machine operators, artisans, craftsmen and young graduates with technical background responded, resulting in the setting up of over 300 enterprises. But what seemed so encouraging on face value did not turnout to be as rewarding as projected. The list of

defaulters was glaring and the reason cited was failure of most of the ventures, pointing out to the lack of capabilities on the part of the promoters. However, this did point towards the innate desire of a certain group of people to opt for entrepreneurship, given a chance.

Those who were already toiling with the idea of conceptualizing an approach that promotes the incidence of entrepreneurship got encouraged with this revelation and initiated a survey to delve into factors that led to the failure of the scheme as also the reasons that prevented the larger society from taking the risk of leaving their jobs and breaking away from caste/community based roles. The study brought six constraints to the fore and these were lack of:-

- motivation to be on their own;
- awareness about viable business opportunities;
- · knowledge on market assessment;
- know-how on business plan preparation (indispensable for securing a loan);
- information about permits and licences, registrations and government formalities to support a business;
- competence to manage a business venture

It was discovered that self doubt, lack of confidence as well as lack of competence based on either one or more of the above factors led to inhibitions in venturing out or failure of the established venture.

So, the questions that stared right in the mind were:-

'If entrepreneurship is the answer, how can entrepreneurs be developed?'

'What measures would ensure a sustained supply of entrepreneurs?'

'How can a healthy support environment be created?'

The concept evolves into a training module

The questions were intriguing, more so, as there was no experience of education, teaching or training developing entrepreneurs or creating business ventures. Besides, there were hardly any believers in the argument that teaching and training can create entrepreneurs successfully. The skepticism in the air about this concept was noticeable.

There were observations that the Indian Institute of Management (IIM) was conducting similar training programmes. However, a structured probe revealed that IIMs were meant to create managers and executives, and not owners and promoters.

However, those who floated the idea, i.e., Dr. V. G. Patel, the then Chief Economic Advisor, GIIC and Shri Manubhai Shah, the then Chairman, GIIC and GIDC were convinced of

its positive impact. "Let the results of the first (landmark) Entrepreneurship Development Programme (EDP) establish the efficacy of the concept," they felt.

The Journey begins

training.

No effort was left untried to ensure the desired impact. A brain trust was formed, comprising business and management educationists, stalwarts from financial institutions, banks, consultants, policy makers and also entrepreneurs. The curriculum of the first ever EDP was (strategically) planned to address the constraints identified, build confidence and create entrepreneurs through structured teaching and

However, the success did not come without hurdles. There was a time when EDPs became immensely popular and states started getting funds for the programme. All kinds of EDPs emerged - ranging from one week to six months, and these were subcontracted to a number of states and non governmental organisations. These organisations were totally unprepared to handle complex human resource development tasks and failed abysmally. Discouraging results earned a bad name for EDPs. This trend began to bother the initiators of the movement. A series of reviews were conducted and these revealed a number of pitfalls in the manner in which EDPs were conducted. Incompetence of the trainer-

motivators was cited as one of the primary reasons. This revelation established a need to create a cadre of trained trainers, and develop well designed, result oriented

training material. The big question was—Who would take up all this? Need for a national resource centre, was, therefore, felt and the seeds of E n t r e p r e n e u r s h i p Development Institute of India (EDI) were sown. The Institute was eventually born in 1983 with the support of premier financial institutions, viz; the IDBI Bank Ltd; ICICI Ltd; IFCI Ltd; and the State Bank of India, with the backing of the Govt. of Gujarat.



A Step-by-Step Approach to Evolving ED1's Activities

The belief that 'Entrepreneurs can be created' has come a full circle - from being a mere concept to delivering tangible results. With growth in terms of support from various quarters, the trend can be comfortably termed as encouraging. However, it's been an arduous journey.

EDI was launched in 1983 with the dictum that Entrepreneurs are not necessarily born but can be created also through training and well conceived interventions. Today, after all the work that has gone into the field, it can be said that the status of an entrepreneur has significantly improved in society. They are given the designation of an 'achiever', someone who can be a role model. This sharply contrasts with the earlier days when they were considered exploiters - money minded, ruthless individuals who monopolized ownership of business.

Knowing the massive task that lay ahead of it, the Institute planned its activities after scanning the environment, identifying areas in need of intervention and researching extensively to find out need for entrepreneurship in the country. Gradually the Institute expanded its wings and every single activity led to a gamut of activities around it, leading to emergence of thrust areas.

Let's catch a glimpse of evolution of related activities under different focus areas.

Laying down the foundation

Since its inception, EDI has played the role of a crucial promoter and monitor of entrepreneurship movement. It began by conceptualising **Entrepreneurship Development Programmes (EDPs)**, and subsequently launched demonstration EDPs



to test their result-orientedness. The first EDP was conducted in Kerala (Trivandrum) in 1983. Fine tuning the programmes led to emergence of a well tested training model on New Enterprise Creation, popularly known today as **EDI-EDP Model.**

As the Institute moved on to adopt the role of a national resource centre in the field, it realized the need to create a **network of ED**

institutions that could adopt this activity and make it widespread. It initiated the process of rendering support to state governments to set up EDI like institutions in their states. Today, together with three other exclusive national institutions, it is successfully backing about 12 state level entrepreneurship organizations. However, the process of this institutionalization also enabled EDI to sense the need of developing human resource that could hold high the baton of entrepreneurship development movement. The need was to spread the activity nationally for greater impact. This, it sought to achieve through a cadre of EDI trained trainers who could carry the pioneering flag. Making a decisive impact, the Institute conducted Trainers' Training Programmes to create a cadre of Entrepreneur Trainer-Motivators (ETMs) who could take the responsibility of teaching entrepreneurship at the state level, effectively. The first Accredited Trainer-Motivators Programme was conducted in 1984 in Ahmedabad. In order to keep the

Subsequently, in 1987, it initiated the **Convention of Entrepreneur Trainer-Motivators** to provide platform to ETMs to brainstorm over the hindering factors and convert these into winning ones. Clubbed with these Meets were the Awards



Youth empowered... through entrepreneurship education

Youth being a promising target, EDI gradually emphasized on the need for taking entrepreneurship into education and implemented **Entrepreneurial Camps** for youths and children. The first summer camp for youth was conducted in 1992 and the first children's camp in 1994. Complementing these efforts were the entrepreneurship skill enhancement activities for teachers, i.e. the

Faculty Development Programmes, launched in 1987 as Teachers' Training Programme, so that the trained teachers could guide students to choose entrepreneurship as a career and also motivate and train them accordingly. Regular Orientation Camps to sensitize the students and the society at large to the charms of being an entrepreneur followed closely. Also, understanding the limitations of a classroom based entrepreneurship development programme, the Institute introduced the Open Learning

Programme in Entrepreneurship in 1995, for imparting knowledge for setting up and managing business enterprise. Knowledge generation through research was also simultaneously emphasized upon and the Institute encouraged applied research cum development in entrepreneurship. This included an indepth study of the need and structuring programmes around this. Setting up of Centre for Research in **Entrepreneurship Education** and Development (CREED)

with the Institute's own funds is a testimony to this. Under the aegis of the Centre, Biennial Conferences on Entrepreneurship are conducted and the biannual Journal of Entrepreneurship is published to shape beliefs on entrepreneurship.

The growing awareness and the need encouraged the Institute to launch a long term, unique, first-of-its-kind education programme in 1998 – the 'Post Graduate Programme In Business Entrepreneurship and Management' to develop

a new breed of young generation entrepreneurs who could handle the nittygritty of the business of their forefathers or set up new enterprises in some burgeoning sectors. It is a zero subsidy course - i.e. no burden on public funds. But, to ensure that deserving students do not miss out due to the fee factor, the Institute has secured fellowships from premier corporate houses and institutions. The success of the course earned it the AICTE approval. In view of the Institute's expertise in entrepreneurship, the University Grants Commission also assigned to it the task of developing curriculum in entrepre-neurship and the Gujarat Text Book Board assigned to it the

responsibility of **developing textbooks** on entrepre-neurship for 11th and 12th standards.

The one-year Post Graduate Diploma in Business Entrepreneurship and Management has not just evolved into a two-year AICTE recognised Post Graduate Diploma in Management-Business Entrepreneurship but has groomed 647 students as entrepreneurs from across the country.







Spreading its wings to reach the grassroots

From efforts to create general self-employment opportunities, EDI strategy expanded to include the concerns of the rural populace. Micro, small and medium scale enterprises were fostered, in the light of the benefits that this sector accrues to the economy. During the meantime, a need was detected and Rural Entrepreneurship **Development Programme** (REDP) Model was evolved by the Institute after a three-state,



Micro-Enterprise and Micro-Finance were used as major strategies to tackle the problems of poverty, unemployment and credit. Today this area has come to incorporate programmes that encourage holistic development of rural area with setting up of science and technology based enterprises, agro clinics by agriculture graduates, programmes on marketing rural products, as also a step ahead: promotion of micro enterprises in urban areas to channelise the

potential of unemployed youths towards self employment, creating gainful employment opportunities. Realizing the need to institutionalise a cadre of professionals who could protect and also advance the principles that govern an NGO, EDI initiated the 'Post Graduate Diploma in Management of NGOs,' a full time academic programme. Simultaneously, the Institute has kept a check on the mushrooming of NGOs of all kinds and hues, by initiating a movement that aims at strengthening the NGO sector

as a vanguard of just and equitable society. It is in this direction that the 'Centre for Governance Studies in Non-Profits' was established at EDI. It contributes to genuine growth of the voluntary sector by addressing issues related to governance.

The much needed programme, 'Post Graduate Diploma in Management of NGOs' has put in place a cadre of 244 NGO professionals.



Bolstering the performance of existing entrepreneurs

Over the years, there were major shifts in strategy. An important one was towards improving performance of existing enterprises and preparing them for growth. The Institute emphasized on sector specific programmes, with the conceptualization of **Growth-cum-Counselling model**. These helped focus on technology selection, introduction of innovations,

promoting tie-ups by networking, new sources of funds, new methods of marketing and development of competencies for exports and dealing with international business. Results were ensured by attaching trained entrepreneurs to EDI - trained business counsellors. The cadre of business counsellors put in place by the Institute has bolstered performance of many a business enterprises. Close on the heels were short duration, skill honing, 'Performance Improvement Programmes' for existing entrepreneurs, including those

struggling with teething troubles. Performance and Growth of Existing Entrepreneurs, therefore, emerged as a significant focus area.

Indian enterprises are also facing challenges from the outside world. Closely linked to this argument is that in India 90% businesses are family-owned or controlled. And, every organisation needs competent managers, executives with competencies, skills and knowledge to make a dynamic organisation, whether private, government or non-government. Fortunately, these skills can be developed. Keeping pace with these market requirements, the Institute launched the 'Small **Industry Management** Assistant Programme (SIMAP)' to produce a cadre of trained youths who could assist in managerial work in small industries so that the entrepreneurs could focus on growth. The programme is now implemented by reputed institutions, including IITs and also state ED institutions.

Subsequently, these programmes

evolved into **'Executive Development Programme'** to cater to the needs of entrepreneurially inclined managers/ executives. It was also observed that in an open market, international companies and other giants face competition from the local ones. **Country specific workshops** conducted by EDI exposed the entrepreneurs to the business environment and factors of the selected countries and made trade easy with these.

However, although these programmes generated results, it was felt that they were somewhere 'isolated' initiatives and could have a larger impact if the 'cluster focus' was adopted to entrepreneurship. EDI adopted the 'Cluster Development **Approach'**, where it guided an enterprise to approach business function in an agglomeration of producers, engaged in manufacturing homogenous products, 'better known as clusters'. Cluster

Development Initiatives brought results in terms of enhanced productivity and increased marketing depth. This effort also protected small scale firms from coming under severe resource pressure, as they


then adhered to benchmarks, like – better products, lower costs, quality, competitive prices, technology and reduced response time, etc. Creation of Consortiums and Common Facility Centres further strengthened their base.

A conducive environment smoothened the road

Although Entrepreneurship Development Programmes started getting conducted systematically, the results, it Brass Parts Cluster, Jamnagar; Diesel Engine Cluster, Rajkot; Automobile Components Cluster, Jalandhar, Ludhiana and Phagwara in addition to many other clusters across the nation have been put on a promising growth trajectory. Handholding support to select clusters in 12 states has also yielded worthwhile results.

was felt, could be made more encouraging. A research Evaluation of EDPs showed that the support system (banks, industry promotion organisations and so on) was not very sensitive to the needs of trained potential entrepreneurs and thus not inclined towards floating a wholesome, growing business environment. An able support system has the inherent potential to give the necessary thrust to entrepreneurship and, therefore, EDI felt the need to rope in the support system so

that an overall conducive environment could be created for growth of entrepreneurship. Sensitization and Stakeholders' workshops to create awareness were thus mounted. Programmes to sensitize government officials were also conducted, and these have contributed to the creation of supportive environment. Gender Sensitization Workshops followed and achieved the dual purpose of orienting women to business and developing a positive attitude of the support system officials towards them. The NGO - Banker **Interfaces** further set in credible relations between the NGOs and the banks, making the scenario more conducive.

enterprise upgradation and investment promotion were given a thrust in Mozambique, Sudan, Yemen and Lao PDR as a part of activities under the 'Inter Regional Centre (IRC) for Entrepreneurship and Investment Training, sponsored by UNIDO and Govt. of India. The focus was on capacity building of specific focal point institutions in these regions through training interventions that followed the concept-to-completion approach.

In order to replicate the success story of promoting first generation entrepreneurs

Going all out

Institutionalizing entrepreneurship across the world was also one of the needs that the Institute identified and addressed. The Institute has institutionalized entrepreneurship in around 80 developing countries. It has helped under developed and developing countries in initiating entrepreneurship development related activities. New enterprise creation,

through training and counselling interventions as also to sustain this movement, the Ministry of External Affairs, (MEA) Govt. of India assigned to EDI the task of setting up EDI-like Entrepreneurship Development Centres (EDCs) in Lao PDR, Cambodia, Vietnam and Myanmar a task that has been successfully accomplished. Also, a series of activities targeted towards strengthening entrepreneurial capabilities in trade negotiations and regional integration in Greater Mekong Sub-Region. The Institute has also been selected by the ITEC

division of the MEA, Govt of India to share its expertise with developing countries by

organizing short term capacity building programmes in various facets of entrepreneurship.

Women form a major section of society and this segment needs to be integrated in the mainstream if the society has to progress. EDI conducted the First Women Entrepreneurship Development Programme in New Delhi in 1985. It has since been conducting programmes that train women to strive for entrepreneurial excellence. The UNIDO sponsored 3-tier project involving sensitization, demonstration programmes and creating a cadre of ETMs for developing women






