Progress from the Field on the Implementation of SVEP



The 1st Edition of Udyamita Udaan (UU)

Welcome to the 1st edition of *UU* - An E-Newsletter designed to update you in brief on the progress of SVEP.

The Start-Up Village Entrepreneurship Programme (SVEP) launched in July 2016 with the aim of creating a supportive ecosystem conducive to rural entrepreneurship. The three boxes below indicate the key stakeholders in this programme. EDI is functioning as a National Resource Agency (NRO) and a Programme Implementing Agency (PIA), piloting the programme in **24** blocks across **11** states. Almost one year down the line, we have seen steady progress being made in these states. This newsletter aims to capture in brief and in time, this pan-India strategy to develop the rural ecosystem into one in which entrepreneurial spirit and endeavour thrives.

Workshop on Systems & Process in the Implementation of SVEP.

In the 2nd week of April, the State Anchors and Block Mentors from all of the 11 states met at EDI Campus, Gandhinagar, to standardise processes & tool for the programme's implementation.

Gujarat turned the heat on (highs of 43°C) for the SVEP workshop as the ever-growing SVEP cohort of around forty met for the first time since the January VE-IT training this year. The workshop was called to bring everyone on to the same page with respect to the processes and tools being used in the programme.

The teams updated each other on their state's current status of implementation and the tools being used for the various activities. Everyone was then divided into groups of 4-6 and asked to identify tools and develop processes with respect to the key activities involved in implementation. Most states are preparing for, or are already at the crucial stage of identifying, shortlisting and selecting entrepreneurs for the



preparation of Performance Improvement Planning and Loan Applications. Accordingly, we focused on developing standard procedures for these current or imminent activities, which are currently being tested in the field.

The workshop included an interaction with the Director of EDI, Dr Sunil Shukla, who sat with the team for an hour-long session to understand the status of implementation. The cohort also heard from the team at Dhwani - a start-up providing customised MIS to organisations working in the development field. They presented to us existing business ideas involving low investment with which our participating states can tie-up in order to fulfil our targets for new enterprises.

BLOCK IN FOCUS – KOLEBIRA BLOCK, JHARKAND

Kolebira Block in Simdega District is a region abundant in Non-Timber Forest Products (NTFPs), such as those of lac, tamarind and chironji. It is a common sight to see locals selling these NTFPs along the main roads of the villages attracting passers-by and local traders. The potential for establishing sub-sector enterprises is high considering the availability of NTFPs as well as its demand in both internal and external markets. The availability and demand of certain NTFP is so high that some of the private players operate the lac and tamarind processing units in this block. Three of our CRP-EPs from Kolebira have been allocated the responsibility of collecting information with respect to market price and fluctuations of NTFPs and approximate cost associated with purchasing processing material. Once the information is collated, we will assess which are the most feasible and viable NTFPs for which to prepare business plans.



Progress Update from the States

We've reached some milestones in the implementation of SVEP. Here is a summary of the key activities we have accomplished to date, across all of the states.

- ✓ All states have identified a Nodal CLF that will be responsible for the disbursement of the Community Enterprise Fund (CEF), with the exception of Odisha. The Odisha Livelihoods Mission is following a different process; instead of identifying a Nodal CLF, the CEF will be distributed to each Gram Panchayat Level Federation (GPLF) in the block.
- ✓ Identification and setup of the BRC office have been completed by all states barring Jharkhand, both blocks in Jammu & Kashmir, 2 of the 3 blocks in Gujarat and 3 of the 4 blocks in Chhattisgarh.
- ✓ Our focus for the months of April and May is preparing and submitting loan applications and Performance Improvement Plans to the BRC for appraisal. Once loans are approved, this will lead to the subsequent grounding of enterprises. Below is a graph which records the efforts put in so far towards this process of enterprise grounding.

Innovation in Enterprise

Cotton Wick Making Machine

Cost: INR 24,800/-Weight: 13.5kg Input: 3.06kg of cotton sliver tape Output: 3kg of cotton wicks per day (8 hours of work) Power consumption: 50 watts



This machine was developed to automate the production of cotton

wicks and increases the production efficiency of users by 400%, thus also augmenting a woman's capacity to earn. An entrepreneur has two options:

- 1. Enter into a contract with the machine supplier where the supplier provides the raw materials and purchases the final products from the entrepreneur. The entrepreneur is paid Rs. 80/kg of cotton wicks produced and can earn up to Rs. 240/day; or
- 2. To purchase the machine outright and operate it as a standalone business where an entrepreneur can earn Rs.350-500/day. In this case the entrepreneur has to ensure the sourcing of raw material and marketing of final products.
