



# EDII mourns Dr. Patel's untimely demise...

If India has spurred its economic performance over the years, a major credit for it goes to entrepreneurship, the seeds of which were sown by Padma Shri Dr. V. G. Patel. Dr. Patel doesn't need an introduction....the entrepreneurship fraternity recognises him as the 'Father of Entrepreneurship Movement.' After a legendary life spanning close to eight decades, the leader who was fondly known was 'V. G.' finally laid down his mantle on 4th April 2019, and settled in peace forever. While the country and EDII will miss him; his learnings and his acumen will continue to guide us. He started out in the 1970s, convincing people about a concept which was alien...But he did not relent. His conviction was such that not just entrepreneurship was accepted by people and the Government, but the concept became so conclusive and rewarding that premier financial institutes agreed to his reason of having a National Resource Institute in Entrepreneurship. He ensured that they pitch in to set up the much celebrated 'Entrepreneurship Development Institute of India (EDII).' And then his critical thinking, astute process of management, and immaculately planned implementation processes made sure that EDII becomes a Centre of Excellence. Today the Institute prides its innovative programmes, wide expanse, perfect implementation and smooth functioning - all of which have been bequeathed by Dr. Patel. Aptly so, he was





honoured with the Padma Shri on March 30, 2017.

With myriad years of yeoman service to promoting entrepreneurship and strengthening its edifice in India and abroad, he has ensured that decision-makers in the Government, students, counsellors, teachers and other resource persons, view 'entrepreneurship' as a primary career option and of overriding importance in catalysing economic growth. Today, we can boast of a large number of entrepreneurship centres and institutes with a distinct place for this discipline in growth policies and planning processes of the Government. And, even on the International level, Dr. Patel had begun the process way too early, i.e., in the 80s. The Institute works with close to 70 developing countries today.

What better credence could this great personality and his work have achieved !!!!!

And, above all, he gave unique stability to EDII. The transition, after he laid down his office on 28 February, 2003, was smooth. After a long stint, he welcomed change with open arms and left a message for leaders across. He taught that succession in management has to be planned in advance and must begin with delegation of responsibilities and decision making leading to a team of competent, tested and trusted managers /executives with one of them being capable of running the enterprise in the absence of the promoter.

His work cannot be summarised in a few pages.....all I can say is – he was a legend whose life itself is a great lesson and the biggest tribute we can pay to him is by following the path that he has shown to us. He was at the helm of affairs in so many areas for EDII, our constant mentor and guide. We lose our greatest supporter with Dr. Patel. But we promise to continue his legacy of bringing in new dynamism, new energy and new vibrations each day.

Entrepreneurship will grow even stronger. The trajectory of entrepreneurship will blossom with our efforts which will emanate from the storehouse of learning which our mentor Dr. V. G. Patel has left behind.

Padma Shri Dr. Viharidas Gopladas Patel, fondly known as VG, a noted economist and hailed as the 'Father of Entrepreneurship Movement' in the country, left for heavenly abode on Thursday, April 4, 2019 at Ahmedabad after a brief illness. He was 79 years and is survived by his wife and three children.

An eminent economist and international figure in the sphere of entrepreneurship, small industry policies and growth management, Dr. Patel had held several key positions in his career marked with laurels and triumphs. He was the Chief Economic Advisor to Gujarat Industrial Development Corporation; Founder Director of Centre for Entrepreneurship Development, Gujarat and Managing Director at Gujarat Industrial & Technical Consultancy Organization Ltd. An institution builder, he set up EDII in 1983 to work for potential and existing entrepreneurs. Dr. Patel's work towards inclusion of entrepreneurship in the formal education system, sensitization of support system, entrepreneurship research in addition to routing several other developing countries on the trajectory of entrepreneurship has been widely recognised. The Government of India also incorporated the EDP approach as a part of its self employment schemes. The Central Government's 'Rojgar Yojana' incorporated entrepreneurship training, based on work done by Dr. Patel.

His book "The Seven Business Crisis & How to Beat Them" (reissued as When the Going gets Tough) is a best seller. Equally acclaimed are "Managing India's Small Industrial Economy" and "Entrepreneurship Development Programme in India and its Relevance to Developing Countries"

He was honoured with the Padma Shri in 2017 for his contribution to development of entrepreneurship in India.

EDII family and the entrepreneurship fraternity has lost a mentor and a guide; a loss which cannot be replaced. EDII family is grieving the loss of its leader; a trailblazer who introduced the country to a distinctive development concept.

We will always hold his mentorship and guidance in high acclaim.

termed conviction, emotion and devotion as the main ingredients of entrepreneurship. He termed capital as secondary. The Minister highlighted several stories of successful entrepreneurs who have achieved success purely on the basis of their passion and will to make it big. Speaking on the use of technology in business, the Chief Guest said, "Technology must be employed judiciously in a manner that we do not become slaves to it. Technology must facilitate our dreams." To elaborate

this, the Minister quoted the example of a village where the locals had been provided with spindles which was powered by solar energy and technology built into it to enable people to enhance their earnings. Speaking on bringing women into mainstream, the Minister quoted Mckinsey's report and said that the Report highlighted that with 42% women's involvement in the economy, China recorded an increase of 41% in their GDP.

Juxtaposing it with Indian Reports, he said that we need to wake up as in 2004, 35 percent of the women were contributing to GDP, while the percentage fell to 24% in 2011. The Minister concluded by beckoning all to take advantage of learning and setting up own enterprises.

On the occasion, Dr. Arun Panda, Secretary, MSME said, "Entrepreneurship requires inner passion to pursue a dream. Institutes like EDII are providing an eco-system to business enthusiasts. MSMEs are the flavour of the season especially after GST was introduced in the country. Out of 1.17 Cr registration in the GST, more than 1 Crore registrations in GST are MSMEs. That means people have started dreaming big." Dr. Panda suggested that EDII must train the key officials of all the 18 tool rooms and technology centres all across this country which are working exceptionally well in skilling people, making them job ready. This training, he said, will enable these officials to impart training in entrepreneurship too, thus ensuring a good success rate in New Enterprise Creation. Adding to this, he said, "Our honourable Prime Minister also announced on November 2, 2018 that 120 more centres - of which 100 small and 20 big centres will be established in the coming 3 years. This will be a huge game changer for the country and for people."

Dr. Sunil Shukla, Director, EDII said, "India is going through a revolutionary phase in which entrepreneurship is receiving tremendous acceptance as a career. With the government promoting MSMEs directly under Start-up India Mission, Make in India and Digital India policies, this sector has flourished like never before during the last couple of years. Increasing number of start-ups, even student start-ups suggests

that the country is all set to make a mark on the global front with innovative and path-breaking ideas."

The function concluded with Vote of thanks by Shri Milind Kamble, Officiating President – EDII and Chairperson – DICCI. Shri Kamble also endorsed the need of technology and innovation as facilitating factors in MSMEs and urged youths to think out-of-thebox. Shri Kamble stressed on the significance of MSMEs for economic growth and encouraged youths to make use of the training to become entrepreneurs. Shri Kamble profusely thanked the dignitaries for extending much-needed support to encourage MSMEs.

The Global Entrepreneurship Monitor (GEM) Survey is the largest annual study of entrepreneurial dynamics in the world. GEM was conceived in 1999 and has since been venerated for the credibility and coverage of its research. The GEM India Team (2015-18) comprises Entrepreneurship Development Institute of India (EDII), Centre for Entrepreneurship Development Madhya Pradesh (CEDMAP), Bhopal; and Jammu & Kashmir Entrepreneurship Development Institute (JKEDI). EDII is the lead institution for GEM India Team.

### **GEM India National Report 2017-18: (Highlights)**

- The Total Entrepreneurial Activity rate is 9.3%. It is 11.5% among people in the age group of 35 – 44 years, followed by 9.2% in 18–24 years and 9.1% in 55–64 years.
- Perceived Opportunity has slightly increased to 44.9% in 2017-18. It was 44.3% in 2016-17.
- Entrepreneurship as a good career choice has increased to 53% in 2017-18. It was 44.4% in 2016-17.

# Developing Countries Build their Capacities to Embrace New Rides

very year the Institute undertakes various capacity building and training programmes for working professionals from developing countries. These are sponsored by the Indian Technical and Economic Cooperation (ITEC) division of the Ministry of External Affairs (MEA), Government of India. The programmes are a concerted effort by the Institute to impart training to working professionals of developing countries and help them jump up the ladders of entrepreneurial success in their respective countries.

53 international participants from 20 developing countries successfully graduated from three capacity-building programmes. All these programmes commenced on January 7, 2019 out of which one programme concluded on February 15, 2019 and the remaining two programmes concluded on March 1, 2019. The programmes comprised of classroom trainings and various field visits.

This year, the programme on Entrepreneurship & Small Business Promotion received 16 participants from 13 countries viz., Botswana,



Cote D'Ivoire, Djibouti, Ethiopia, Guatemala, Lesotho. Malavsia. Mongolia, Nigeria, South Sudan, Tanzania, Tonga and Uzbekistan. Directed by Mr. Prakash Solanki, Faculty-EDII, the programme focussed on developing a cadre of hardcore professionals who can work for the promotion of economic activities in developing countries. The content was specially designed for professionals from different backgrounds that covered various parameters like Business Opportunity Identification, Business Plan Preparation, Analysis of Competencies and Assessing Potential Entrepreneurs and Effective Business Counselling. "The participants learnt about preparing viable business plans and enhancing leadership skills. They were equipped with new tools and techniques to set up a new enterprise and also facilitate growth of existing small enterprises. I am delighted to share that we have received excellent feedback for the programme," remarked Mr. Solanki.

Speaking of the second programme, Entrepreneurial Management programme received 18 participants from 7 different countries viz., Afghanistan, Egypt, Ethiopia, Guinea, Kenya, Mongolia and Zimbabwe. The programme mainly focussed on inculcating a spirit of entrepreneurship among the participants by helping them sharpen their knowledge skills and practice entrepreneurial management effectively. The programme also enabled participants to practice innovative

# Targeting and Celebrating Inclusive Growth....

any a time people with unique talents and abilities are disillusioned by factors which appear to be huge problems at face value but are actually quite addressable if targeted strategically. Their talent would blossom under welldesigned training intervention, guidance and mentorship. Especially youth, with such support will not just get into worthwhile initiatives, but will also positively impact the lives of several around them. The members of the disadvantage communities are generally at a loss on account of many social stigma and economic limitations. Entrepreneurship is one area which can give such individuals a new lease of life. Training and experience in entrepreneurship can open up several avenues for their livelihood and many more around them. They can turn into job givers from being job seekers. Against this backdrop, EDII launched Entrepreneurship Development Programme to train over 750 youths in entrepreneurship especially from the SC sections of the society.

The project involves a series of 20 residential

programmes on entrepreneurship development and 10 residential Small Industry Management Assistant Programmes (SIMAP). While the former will target training 500 youths in setting up and managing own enterprise: the latter will ensure imparting skill sets to 250 youths so that they become employable. In all 250 enterprises are expected to be established with employment generation for around 1000 people over a period of time. Investment mobilization expected by these 300 units is to the tune of Rs. 10 to 12 crore over a period of time. The duration of each programme is 4 weeks with participants from across districts of Gujarat. The programmes are sponsored by Scheduled Caste Welfare, Social Justice and Empowerment Department. The first programme in the series was inaugurated on February 12th 2019 at the hands of Chief Guest Shri Ishwarbhai Parmar, Hon'ble Minister of Social Justice and Empowerment, Gujarat State inaugurated the first Entrepreneurship Development Programme for SC Youth. ## The Future of India Lies in its Villages... Start-up Village Entrepreneurship Project

s National Resource Organization (NRO) for Ministry of Rural Development, Government of India's 4-year (i.e., January 2016 – March 2020 and March 2017 – March 2021) Start-up Village Entrepreneurship Programme (SVEP), EDII implements the program in pilot blocks of select states with State Rural Livelihood Mission (SRLM) and also provides support to state missions to further saturate SVEP intervention in the state. SVEP has been launched in 57 blocks across 11 states.

Through SVEP, EDII's main aim has been to create rural entrepreneurs by developing a sustainable model for Village Entrepreneurship Promotion through various integrated Information & Communication Technologies (ICT) and tools for training and capacity building and enterprise advisory services. With the help of SVEP, rural entrepreneurs are able to access finance from NRLM-promoted SHGs, federations and banking systems including the proposed MUDRA bank. This initiative has, therefore, strengthened Entre-preneurship Ecosystem, Institutional Ecosystem and Financial Ecosystem.

A total of 19549 Business plans have been approved by Block Resource Centre Committee in establishing enterprises across the nation. An amount of ₹ 54.65 cr has been disbursed so far. The repayment rate on an average across 57 blocks is approximately 95%. In order to carry out the colossal task, currently 624, (310 Female and 314 Male) community resource persons have been suitably trained under the program.

# 13th Biennial Conference..... Encouraging Entrepreneurial Perspectives

ntrepreneurship is all about the readiness to take risks, create structures and handle a business with a dynamic mindset. In India, entrepreneurship and start-up activities have grown immensely over the last two decades. Not only there is a huge advancement in the technology and innovation sector but the ease of finding source for funds and capital has encouraged more and more people to take to start-ups. Entrepreneurship is certainly creating an atmosphere of excitement in the world. From family businesses to innovative start-ups and social enterprises, entrepreneurship has come a long way. Research in the area has been a major factor that has brought the trends and nuances to the fore and has ensured interventions in the right areas. Over the past 24 years, the Biennial Conferences on Entrepreneurship have been organised by the Centre for Research in Entrepreneurship Education and Development (CREED) at EDII to probe the various aspects of entrepreneurship and to bring the researchers from the nation and across the world on a common platform. The 13th International Biennial Conference on Entrepreneurship as inaugurated by Padma Shri Late Dr. V. G. Patel,

Noted Expert on Entrepreneurship and Founder & Former Director of EDII, Ahmedabad. The three-day Conference witnessed over 235 academicians, practitioners, thinkers and researchers engaged in the field of Entrepreneurship from prestigious national and international institutions. Over 300 papers were received, out of which 147 papers were accepted including 16 papers from international academicians from countries like Bangladesh, France, Iran, Israel, Mexico, Nigeria, Norway, Poland, Switzerland and Russia.

Padma Shri Late Dr. V. G. Patel in his inaugural address congratulated the institute for organizing this conference and significantly broadening the frontiers of the important discipline of entrepreneurship. During his brief speech, he spoke about the early years of India during the 70s when setting up an enterprise was all about filling 42 different sorts of forms and even waiting 2 years for the sanctioned loan amount. It was then, he said, they removed the constraint of money that was found out to be the major problem for starting of a business. Dr. Patel realised that it was a beginning of addressing a big problem that India faced in setting up enterprises. Hence, he spoke to various technologists, artisans, small time businesses to find out the other problems that stopped them from succeeding.



That was how the first ever Entrepreneurship Development Programme Model was evolved wherein a total of 200 people applied and 40 were selected. The success of the model led to several institutions coming up with similar programmes which started failing and thus was felt the need to create a national level institute with a cadre of competent trainers, and so EDII came into being. Dr. Patel further elaborated on the concept of entrepreneurship, the growth and entry level barriers and how the changes must be effected to achieve better in the existing scenario.

Dr. Sasi Misra, Conference Chair, EDII gave a briefing on the conference informing all that the themes to be covered include; Entrepreneurship Perspectives & Practices, Entrepreneurship Education, Women Entrepreneurship, Social Entrepreneurship, Innovation, Agripreneurship, Sectoral Entrepreneurship, Startups, Incubators & Accelerators etc.

The Conference promoted and advanced the understanding of entrepreneurship theory and research in the above mentioned areas. The conference successfully imbibed an entrepreneurial mind-set among the researchers with the hope that they will delve further into the finer aspects and seek

to establish a connection between entrepreneurship and the changing market dimensions on the fast growing 21st century.

Dr. Patel requested researchers to continue upgrading themselves on research methodology and take up some pertinent research topics like:

- Why close to 40 % of the start-ups fail in the first three years?
- What are the behavioural qualities needed in potential entrepreneurs to succeed; need to review the existing selection tests?
- What creates a great institution in the wake of the fact that out of 11 Entrepreneurship Development institutes in the country, close to 9 have failed?
- Why do family businesses fail by the second or the third generation?

programme was open to women-owned businesses in the service sector for the first time in the year 2018. The two-phased WEDP selected 40 women for training programmes at Delhi and Bangalore. The WEDP 3.0 Bangalore cohort of 17 Women Owned Business [WOB] attended the first phase of the training during 6 -10 December 2018. Bangalore Cohort had an interesting mix of businesses, including; products like edible cutlery, tender coconut based homemade masala and chutney powders, liquid detergents. terracotta jewellery, organic cosmetics etc. Apart from these, various women from service based sectors also participated. They were from different backgrounds education, consulting, research, recruitment, events organizing, landscaping, renewable energy, Artificial Intelligence (AI) based CRM, computer network systems, film-making and advertisements from across Southern India, such as; Bangalore. Hyderabad, Tamil Nadu and Kerala.

The Phase II of the Bangalore cohort kick-started from 17 December and concluded on 19 December 2018. The class room sessions during both the phases were planned to include Subject Specialists from Walmart India. ndia is modernising in the true sense of the term. The country is stepping up its strategies to target Inclusive growth − growth for all sections and segments of society. The theme this year was 'Manufacturing New India' where the speakers addressed the audience on the potential of Indian start-ups among the upcoming technological developments in the world. According to the experts present at the event, they had different views on the start-up ecosystem in India. They said, even though the start-ups were growing folds since the last few years they still need to reach various remote places to ensure overall inclusive development particularly economically and in general.



Dr. Ronald Mainardus, Head of Regional Office-South Asia, Friedrich Naumann Stiftung, spoke about the overall growth of the start-up ecosystem in India. He said, "Main problem of India today is poverty and

liberalisation of the market is the major solution to this problem. Entrepreneurship is an essential element of

development and liberalised market that can reduce poverty."



With vernacular language and other regional languages taking a back seat, Mr. Rahul Dev, Advisor, Speakers' Research Initiative, Loksabha had a completely different take on languages and business. He said.

"Entrepreneurship in rural areas should be promoted through local language as it helps in connecting business. Through local language, rural entrepreneurs are provided key confidence support that they require to take forward their business ideas and skills."



While Mr. Savji Dholakia, CEO, Harikrishna Exports agreed with Mr. Rahul Dev, he also emphasised on gut feeling while starting an enterprise. He said "Fear is the primary reason behind

unsuccessful business. Many entrepreneurs put their best brains for executing their key ideas; but somewhere it lacks in connecting with the people. Any decision taken from the heart will be successful, unless at the cost of damage to nation, family or entrepreneur themselves."

Mr. Balaji Vishwanathan, CEO, Invento Robotics



focussed on the revenue part of startups and said, "Only way a country can become prosperous and well known is by harnessing the entrepreneurship capability. At times we are so enamoured by the ideas that other important things like revenue takes a back seat. The key ailment of any start-up should not only be about delivering a purpose but also ensuring that the revenue keeps coming in. Revenue and purpose sets up a statement of being a great company or start-up."

One of the highlights of the sessions during the 3-day event, post inauguration was that women were breaking free from the orthodox clutches of society and were taking a step towards success by doing what they liked. It was noted that women were breaking free from

traditional business opportunities and were proactively considering hi-tech opportunities. The speakers and the mentors pointed out that the economy and society needed resilient interventions in this area, specifically in hinterland where traditional businesses still thrived and for that all the stakeholders of the ecosystem had to play a big role.

Apart from the panel discussions, speaker and mentoring sessions and workshops, the events included candid fireside chats, 'The Big Pitch 3.0' and Blood Brothers Music Concert.



- High status to successful entrepreneurs has increased to 56.2% in 2017-18. It was 47.7% in 2016-17.
- Media attention to entrepreneurship has increased to 44.8% in 2017-18. It was 39.7% in 2016-17.
- Perceived Capability has slightly decreased to 42.1% in 2017-18. It was 44% in 2016-17.
- Fear of failure has increased to 39.6% due to many policy formulations. It was 37.5 percent in 2016-17.

# GEM India National Report 2017-18: (Constraints and Recommendations)

 The GEM 2017–2018 has identified (i) government policies, (ii) financial support and (iii) cultural and social norms, as major constraints to entrepreneurship in India.

#### Major Recommendations:

- Improvements are desired in entrepreneurship education and training from an early stage.
- Policy formulations need to focus more on new and existing businesses.
- Financing policies for Tech-based Start-up and New Businesses need to be formulated.
- Increased involvement of government in terms of more programs on enhancing tech-knowledge as also competency building will promote technologybased enterprises.
- Efforts towards creating favorable cultural and social norms towards business and entrepreneurship will create wider acceptance for entrepreneurship.
